

INVITATION TO TENDER

FOR INTERNATIONAL BROKERAGE SERVICES FOR THE SALE OF WATER TAXI VESSELS

The NATIONAL INFRASTRUCTURE DEVELOPMENT COMPANY LIMITED (NIDCO) would like to invite Contractors to submit a proposal for International Brokerage Services for the sale of three (3) Water Taxi Vessels.

DESCRIPTION OF THE VESSELS

On May 23rd 2008, the H.C. Milancia was acquired from GATX International Limited and the H.C. Olivia was acquired from VT Leaseco Ltd. Both vessels are 27m high speed Catamarans, with a passenger capacity of 150 persons. The vessels passed the full five-year survey by DNV Classification Society which was conducted on April, 2009.

The M.V. Su (SU) was purchased on September 01, 2008 from Unal Caginer of North Cyprus. The SU is a 45m high speed Catamaran with a passenger capacity of 449 persons. Since its purchase the SU has undergone extensive repairs but remains docked at Inter Isle Construction Company Limited (Inter Isle) in Chaguaramas as all the required refurbishment works were never completed to facilitate the vessel being placed into commercial operation.

SCOPE OF WORKS

The M.V. SU, the H.C. Olivia and the H.C. Milancia are now to be sold and as such International Brokerage Services will be required to facilitate same.

The M.V. SU will be sold on an "as is where is" basis along with certain electronics and engine parts which are also available for purchase, whilst the H.C. Olivia and the H.C. Milancia will be sold subject to regular conditions of sale.

International Brokerage Services are catered to be undertaken on a commission basis.

PROPOSALS

The proposal price for 'International Brokerage Services for the sale of three (3) Water Taxi Vessels' shall be **exclusive of Value Added Tax (VAT).** Your Proposal must remain valid for a minimum period of ninety (90) days after the date of opening of the Proposals.
